CAFA Mission Statement:

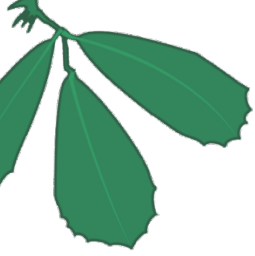
- To represent and protect interests of alfalfa and forage growers across California, and act as a communication link for the alfalfa and forage industries; and
